ORDER ON UNOPPOSED MOTION TO WITHDRAW AS COUNSEL OF RECORD

6. Defendant CHARLES J. STRATMAN shall either (a) retain new counsel permitted to practice before the Court and who shall file a Notice of Appearance by **January 4, 2026**, or (b) file a Notice of Intent to Proceed *Pro Se* by **January 4, 2026**. Failure to comply with this Order will result in a default being entered against CHARLES J. STRATMAN without further notice.
